##### AFFIDAVIT

1. That Sri Rajeshwara Educational Society is a registered Society under the Sri Rajeshwara Educational Society.
2. That the Sri Rajeshwara Educational Society is of Non-Proprietary Character.
3. That no member of the School Management Committee is related to each other.

4. That the school is run as community service and not as a business and that commercialization does not take place in the school in any shape whatsoever.
5. That no part of income from the institution shall be diverted to any individual in the Society registered under section 25 of the Companies Act, 1956 School Management Committee or to any other person. The savings, if any, after meeting the recurring and non-recurring expenditure and contribution to developmental depreciation and contingency funds may be further utilized for promoting the school.
6. That school is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization or body organization.
7. That the school will not open classes under CBSE pattern particularly class IX/X and will not use CBSE name in any manner without obtaining affiliation.
8. That the principle and the correspondent/ manager of the school having individually gone through the provisions contained in the affiliation and examination byelaws, directions issued from time to time and the laws of the land.
9. That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour laws etc with respect to the school and staff of the school.
10. That the school will ensure that the building safety, fire safety, water safety, Health and Hygiene certificate are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed terms.



11. That the school will ensure that all required infrastructure is available with the school before starting classes
12. That the school will ensure that sufficient number of qualified teachers as per the provisions contained in affiliation bye- laws are available with the school before starting classes
13. That the school will follow the provisions related to fee contained in affiliation bye- laws and will disclose the details of the fee to the students/parents every year before start of session without restoring to any hidden charges in the heads of the fee.
14. That the school will not coerce any student/ parent to buy books/ stationery/ uniform from any particular shop.
15. That the school shall strive to make efforts for conservation of environment
16. That the school will ensure that the school will fulfills all essential retirement before applying for affiliation and will fulfill all other conditions post affiliation and comply with all the general rules as given in the affiliation bye-laws or notified from time to time.
17. That the school will not start CBSE pattern classes without submitting a commencement certificate to the effect that the School has completed with all the conditions imposed by the CBSE and the post-affiliation conductions contained in affiliation bye-laws along with the general rules
18. That the state pattern classes IX to X running prior to the affiliation of CBSE would be sponsored at State Board Examination and state pattern classes IX to X will be closed in phase manner and state pattern classes 9 to 10 will not be opened on conferring upon Affiliation from CBSE.
